## **Summary Care Record**

There is a new central NHS computer system called the Summary Care Record (SCR). It is an electronic record which contains information about the medicines you take, allergies you suffer from and any bad reactions to medicines you have had.

## **Why do I need a Summary Care Record?**

Storing information in one place makes it easier for healthcare staff to treat you in an emergency, or when your GP practice is closed.

This information could make a difference to how a doctor decides to care for you, for example which medicines they choose to prescribe for you.

## **Who can see it?**

Only healthcare staff involved in your care can see your Summary Care Record.

If you choose to opt out of the scheme, then you will need to complete a form, which can be downloaded from the internet or ask the reception team for a copy.

## **Accountable Named GP**

Upon registering at the practice you will be allocated a named accountable GP to take responsibility for the co-ordination of your healthcare within the appropriate services.

This does not imply personal availability of your named accountable GP, throughout the working week and does not imply they will be the only GP or clinician who will provide you with healthcare. For further information please see reception team.

### Scoring:

A total of 5+ indicates increasing or higher risk drinking.  
An overall total score of 5 or above is AUDIT-C positive.
